Volgrip LH consists of a layer of sodium bentonite, placed between the fabric and the polypropylene or polyester non-woven.

Bentonite contains natural crystalline silica in quantities of less than 6%.

All components are needle punched together.

The product does not contain components classified as dangerous for human health or the environment, or with occupational exposure limit values established at community level.
